## REPLACEMENT - TAKEOVER BID FOR STRIKE RESOURCES - STATUS OF DEFEATING CONDITIONS

*This announcement replaces the announcement uploaded to ASX earlier today (with the announcement title " Takeover Bid for Strike Resources – Status of Defeating Conditions") to replace the notice attached to that announcement with the correct notice.*

- 1 On 26 August 2015 Bentley declared all takeover offers dated 31 July 2015 (**Offers**) under Bentley's off-market takeover bid for all the ordinary shares in Strike contained in Bentley's bidder's statement dated 17 July 2015 (**Bidder's Statement**) free from all defeating conditions as set out in Section 8.7 of the Bidder's Statement except for the condition in section 8.7(g) of the Bidder's Statement (No Prescribed Occurrence).
- 2 The Offers remain subject to the condition in section 8.7(g) of the Bidder's Statement (No Prescribed Occurrence). As at the time of giving this notice, Bentley is not aware of any event or circumstance having occurred or existing of the kind referred to in this condition.
