CBG Fund Details as at 30 November 2017

As at 30 November 2017, Bentley had ~\$3.65 million (29.29% of its net assets) invested in the CBG Australian Equities Fund (Wholesale) (**CBG Fund**) (31 October 2017: ~\$3.58 million (31.78%)).

About the CBG Fund

The monthly performance of the CBG Fund for October 2017 was $\pm 1.9\%$ (31 October 2017: $\pm 3.4\%$ compared with its benchmark performance (S&P/ASX 200 Accumulation Index) of $\pm 1.6\%$ (31 October 2017: $\pm 4.0\%$).

The CBG Fund is a wholesale fund not open to retail investors. The objective of the fund is to outperform the S&P/ASX 200 Accumulation Index over the medium term. The Investment Manager is 'style neutral' and invests in growth stocks, value stocks, stocks with maintainable dividend yields and special situations.

CBG Fund details as at 30 November 2017:

- The equity weighting was 96.44% (31 October 2017: 95.82%)
- 81.54% of the equity portfolio is invested in companies contained within the S&P/ASX 200 Index (31 October 2017: 82.50%) with the balance of 18.46% invested in companies outside of the S&P/ASX 200 Index (31 October 2017: 17.50%); and
- The equity portfolio contained 44 holdings (31 October 2017: 43 holdings).
