
PERFORMANCE COMMENTARY

International markets rose strongly in May, S&P500+3%, UK+3.4%, Japan +2.4%, whereas Hong Kong fell, -0.3%. Positive economic data and an (early May) fall in the oil price drove economic sensitive sectors such as IT (6.6%) and Consumer Discretionary (3.0%). This environment helped auto stocks along, as did news that billionaire Kirk Kerkorian was looking to lift his stake in GM. Utilities, telcos and other defensive issues lagged. Investment banks Goldman Sachs and Morgan Stanley also underperformed, ironically on negative broker reports. The AUD fell approximately 3% which added to the strong local currency returns.
