### FSP Fund Details as at 31 July 2010

As at 31 July 2010, Bentley had ~47% (~\$14.35 million) of its net assets invested in the FSP Equities Leaders Fund (**FSP Fund**).

#### About the FSP Fund

The monthly performance of the FSP Fund for July 2010 was 7.5% compared with its benchmark performance (S&P/ASX 200 Accumulation Index) of 4.5%.

The FSP Fund is a wholesale fund not open to retail investors. The objective of the fund is to outperform the S&P/ASX 200 Accumulation Index over the medium term. The Investment Manager is “style neutral” and invests in growth stocks, value stocks, stocks with maintainable dividend yields and special situations.

FSP Fund details as at 31 July 2010:

- The equity weighting was 96% (30 June: 99.5%);
- 81.7% of the equity portfolio is invested in companies contained within the S&P/ASX 200 Index (30 June: 81.4%) with the balance of 18.3% invested in companies outside of the S&P/ASX 200 Index (30 June: 18.6%); and
- The equity portfolio contained 46 holdings (30 June: 46 holdings).
